CHARGE: Develop a strategy to educate students about judicial clerkships and assist them in obtaining those clerkships; developing any infrastructure that might improve our efforts in this area; guide the Dean in outreach to judges to improve our clerkship yield.

HIRING TRENDS

<u>National</u>: The Clerkship Committee discussed national trends in clerkship hiring, including the breakdown in federal hiring plan, greater lateral hires, and more candidates from top-tier schools. The Committee determined that the law school should support students' decisions to apply early to judges who hire off plan in order to give them every competitive advantage given the uncertainty of the federal hiring plan. The Office of Career Service conducted outreach to each federal judge in New Mexico to determine their hiring preferences and timeline for the 2014 term and shared that information with all 2L students.

<u>New Mexico</u>: The committee discussed feedback from one local judge regarding concern for the caliber of UNM Law graduates and their ability to analyze complex legal issues. Employer practices regarding post-clerkship offers to summer associates were also discussed. In particular, unlike in other larger markets, New Mexico firms often will not guarantee a summer associate a position at the firm at the conclusion of a clerkship. Because students often hope to secure such high-paying positions after a clerkship, some students decide to forego a judicial clerkship for a guaranteed firm position at graduation.

STUDENT OUTREACH

<u>Student Programs</u>: The Clerkship Committee planned and executed the following student programs:

<u>Faculty Outreach</u>: Ted Occhialino sent an email prepared by Dean Harrigan and edited by committee members to faculty requesting that they identify strong judicial clerkship candidates. The email was timed to coincide with the submission of fall semester grades and encouraged faculty to consider not only students with strong academic performances, but also candidates that would do well under a more "whole-person" review, which many of our state judges use to evaluate candidates.

INFRASTRUCTURE

The Committee discussed and the above email addressed best practices with regards to serving as recommenders. For example, while some recommenders provide students with a copy of their letters as a matter of course, others found that practice to be inconsistent with their view that letters should be kept confidential in order to maintain the integrity of the recommendation. The Committee also discussed the possibility of placing phone calls to judges to advocate for strong candidates. The faculty members were resistant to this kind of outreach because the culture in New Mexico is different and historically New Mexico judges will contact faculty to discuss possible candidates.

OUTREACH TO JUDGES

As recent graduates of the law school have traditionally done well in securing clerkships with the New Mexico Supreme Court and the New Mexico Court of Appeals, the committee decided to focus outreach efforts on federal judges. A plan was designed to utilize the professional relationships and goodwill created by senior faculty members with members of the federal bench to help develop relationships between junior faculty members and federal judges. An email was circulated to senior faculty members requesting that they identify federal judges with whom they have a relationship and asking them to consider arranging a brief meeting or lunch with the judge and junior faculty members.

The implementation of this outreach initiative was delayed in part because of the family medical leave of the Committee Chair and the relatively last minute acceleration of the federal hiring plan's critical dates from September to June.

YIELD

Seventeen members of the Class of 2013 secured 18 clerkships (one December graduate, Julia Crooks, secured two). Note, another December graduate, **Secured two**, had a clerkship from February 2013-August 2013. Thus, for reporting purposes to the ABA and *US News*, we will report 16 clerkships. This is the greatest number of clerkships on record for the University of New Mexico School of Law. Names have been redacted for students who have not given permission for their employment data to be released.
