I. Approval of Minutes from December 7, 2010 Faculty Meeting

- a. A motion was made and seconded to approve the minutes from the December 7th faculty meeting as presented.
- b. There was no further discussion, and the motion received unanimous approval by a show of hands.

II. 2404 Remodel

- a. The faculty meeting was noticed and held in room 2404 to allow faculty the opportunity to view the room's remodeling completion.
- b. IT/Media staff member, Tony Anderson, provided a brief showcase/virtual tour of the room's media features.
- c. Both he and Cyndi Johnson offered faculty members individualized tutorial services should anyone feel them necessary.

III. Announcements

- a. Dean Kevin Washburn
 - i. Acknowledged Professor Christine Zuni Cruz receipt of the 2010 Pincus Award at the AALS Annual Meeting earlier in January 2011.
 - ii. Welcomed Rob Schwartz back to the Law School.
 - iii. Reported there was good news with regard to end-of-year giving, details of which would, in part, comprise a development report by Hannah Farrington at a later meeting.
 - iv. Informed faculty that one of the outstanding hiring offers was declined, and he is proceeding to presenting an offer to the next candidate previously approved by the faculty.
- b. Professor Gloria Valencia-Weber announced the various upcoming events honoring SOL's deceased colleague, Tim Vollmann.

- IV. Budget Update Associate Dean Carol Parker
 - a. Current economic forecast somewhat brighter than previously expected.
 - b. UNM lobbyists' current focus is on eliminating the funding formula tuition credit. Dean Parker urged faculty to be willing to play a role in educating political leaders, if requested.
 - c. Both current budget proposals (LFC & DFA) will hit RSPS fundingpretty significantly.
 - d. Dean Washburn reminded everyone that another of SOL's graduates, Nate Gentry, has recently been elected to the legislature, and he encouraged faculty to send congratulatory notes.
- V. DWI/DV Prosecution in Practice Program Professor Hope Eckert
 - a. Professor Eckert provided the background of the development of the program.
 - b. She described the model the program follows, as well its purpose, goal, philosophy and logistics. The students are very positive about their experiences, and Professor Eckert is receiving a great deal of community interest and support.
 - c. Questions and conversation were invited, but none followed.

VI. Admissions Update – Assistant Dean Susan Mitchell

- a. Assistant Dean Mitchell
 - i. Provided a handout copy of information from which she elaborated.
 - ii. Noted that applicants and applications are both down about 10% nationwide.
 - iii. Described the various costs of attendance and means available to students to attempt to meet them.
 - iv. Presented application statistics, including a comparison among the last few years.
 - v. Recruitment efforts covered a much wider scope than ever before. She may ask faculty to reach out personally to applicants interested in specific areas, particularly New Mexico residents; and is interested in input regarding different strategies.
 - vi. A period of questions and discussion followed her presentation.

VII. NM State Bar & Supreme Court CLE and Professionalism Rules Proposals – Dean Kevin Washburn

- a. Dean Washburn briefly described the two proposals being considered, accompanied by ongoing discussion among the faculty with regard to their potential impacts:
 - i. Changing the current required one hour in each professionalism and ethics to a 2 hour total requirement in any combination.
 - ii. Eliminating the professionalism requirement and replace it with a mentorship program in which every first year lawyer gets a mentor.
- b. After continued conversation, Dean Washburn asked whether there was consensus among faculty for one proposal over the other. There was a strong majority in favor of the combined professionalism/ethics proposal. Dean Washburn stated he would communicate the faculty's viewpoint and ideas to Chief Justice Daniels.
- VIII. ABA Standing Committee on Federal Judicial Improvements, Media Alerts Project, 10th Circuit Dean Kevin Washburn

- a. Dean Washburn described this ABA initiative to get law schools to adopt a circuit court and summarize (blog) the key cases that are coming up for argument.
- b. Is this something we can take on?
- c. Conversation ensued regarding the ramifications, logistics and feasibility. No definitive action was taken, although it was suggested that a call be made to both of the schools doing this for their respective courts in Texas and Arizona.
