- I. Announcements
 - a. Dean Washburn highlighted the 50th Anniversary Issue of the Natural Resources Journal.
 - b. Dean Washburn, with some supplemental briefings from Professors Mathewson Pareja, provided an update on the faculty recruitment process and the current status of each of the outstanding offers.
 - c. Dean Washburn briefly touched on the recent achievements of various faculty members:
 - i. Professors Gloria Valencia-Weber and Antoinette Sedillo Lopez have an article that continues to receive Top-10 awards on SSRN.
 - ii. Professor Christine Zuni Cruz will be awarded the Willima Pincus award at the AALS Annual Meeting in January. This is the highest national clinical award, and UNMSOL's second.
 - Professors April Land and Barbara Creel were well received at the UCLA/University of London Seventh International Conference at Lake Arrowhead.
 - d. Dean Washburn and Archivist David Myers provided additional information on, and encouragement to attend, the upcoming 60 for 60 gala event.
- II. Mandatory Training on Safety and Ethics, and on Sexual Harrassment
 - a. Dean Washburn reminded faculty to fulfill the mandatory training on Safety and Ethics, and Sexual Harrassment, which is a job requirement.
