#### I. Announcements

- a. Professor Sherri Burr detailed the upcoming Spring Faculty Colloquium series.
- b. Dean Kevin Washburn
  - i. highlighted requests for nominations for both the 56<sup>th</sup> Annual Research Lectureship Award and the UNM Teaching Awards.
  - ii. announced the finalization of John Feldman's position change to research professor/coordinator of alternative dispute resolution programs.
  - iii. gave a brief legislative update regarding bills being introduced that could potentially impact the Law School.
  - iv. presented an admissions synopsis to date.
  - v. provided an update on Judicial Selection.
  - vi. apprised faculty of his February travel schedule.
  - vii. displayed an example of the integrated budget spreadsheet Associate Dean Carol Parker created to serve as a budgeting tool for the Law School's complex needs.
- c. Professor Barbara Bergman invited faculty to the Career Services Manager candidate presentations on January 30<sup>th</sup> and 31<sup>st</sup>.
- d. Dean Parker invited faculty input regarding the development of the old faculty lounge and other underutilized law school space.

## II. Approval of December 12, 2011, Minutes

- a. A motion was made and seconded to approve the minutes, as presented, from the last faculty meeting.
- b. There was no further discussion and the motion received unanimous approval.

### III. Oil and Gas Candidate Consideration - Dean Kevin Washburn

- a. Dean Washburn distributed the information packets previously produced by the Appointments Committee with regard to the candidate under consideration.
- b. The Dean reminded faculty of the background for this position, including
  - i. the December 2011 faculty vote which garnered the candidate the appropriate threshold as acceptable for hiring consideration;
  - ii. and the Dean's follow-up with donors and the provost regarding creatively funding this position.
- c. Professor Reed Benson provided additional information and background on the candidate.
- d. A brief period of discussion followed.
- e. Dean Washburn asked faculty to vote by secret ballot in the following manner:
  - i. Each faculty member was asked to write yes or no to authorize a hiring offer.
  - ii. The candidate received more than the 60% threshold necessary, and Dean Washburn told the faculty he would contact the candidate as soon as possible.

#### IV. Indian Law Visitor Hire Consideration

- a. Professors Antoinette Sedillo Lopez and Christine Zuni Cruz briefly touched on this subject, sparking some conversation among the faculty.
- b. Professor Zuni Cruz confirmed she is still in the process of interacting with each faculty member individually on this matter.
- c. A packet on the candidate will be prepared and placed in the old faculty lounge for consultation by faculty members.
