## I. Announcements

The following announcements were made:

- a. Professor Eileen Gauna announced that Professor Marsha Baum, who was currently in Tasmania, was encouraging other faculty to consider visiting Tasmania.
- b. Professor April Land congratulated Professor Burr and the Art Committee for the success of the staff art show that was launched on January 11. Professor Burr announced that the current show would be on display until spring break, when the next exhibit featuring student art work would be displayed.
- c. Professor Alfred Mathewson announced that the Africana Studies program is hosting a kick-off brunch for Black History Month, on January 26. This year's theme is "The 150<sup>th</sup> Anniversary of the Emancipation Proclamation."
