I. Dean's Search Committee

The meeting was held to discuss faculty appointments to the Deans' Search Committee. The topic for discussion was "what would make a good Committee, a general sense, of what a balanced Committee would look like as far as faculty appointed," and then continue with nominations and voting with that in mind.

Open discussion took place regarding the issues of importance, i.e., race, gender, teaching area, as well as how many faculty and emeritus faculty would be nominated.

A motion was made and seconded to send nine names (8 faculty and 1 Emeritus) would be chosen and forwarded to the Provost in alphabetical, unranked order.

After further discussion, an amendment to the motion was made that the three Emeritus receiving the most votes would be forwarded to the Provost, allow him the option of choosing the best fit to balance the Committee.
