Announcements

I. Announcements

- Dean Herring introduced newly-elected SBA officers.
- Professor Sherri Burr was named the 2014 New Mexico Communicator of Achievement by the NM Press Women.
- Deans Herring and Gauna reminded faculty that they need CV's and course syllabi from Summer 2013 Summer 2014 for the ABA self-study.
- Admissions has received 110 seat deposits and would like to receive 125 -
 - There are still outstanding offers have until mid-May to respond;
 - Diversity of class of 2017 is similar to previous groups however there is a decline in Native American students. Will work closely with PLSI over the summer;
 - \$180,000 more in scholarship money to offer students, surpassing our goal of \$90,000 in new giving;
 - As of now, median LSAT scores have slipped but median GPAs have increased.
- A request for office space for PLSI professors to use over the summer.
- W.K. Kellogg Planning Grant Professor Cannon gave a short update on receipt of \$90,000-plus planning grant.
- Faculty raises Professor Scott Hughes discussed how the raises for faculty were determined by the University and how they were being funded.
- Dean Herring indicated that the School of Law's budget was cut by \$60,000 for the next fiscal year as a result of funding the central University raise pool.
- Innovation Academy growing out of the Innovate ABQ partnership between the city and the University.
 - In early stages of development;
 - Assist with the development of new businesses in ABQ and NM;

- Business and Tax Law Clinic will likely have some presence within the program.
- Restructuring of the NM Bar Exam Bar Examiners considering a diploma privilege representatives from the Law School faculty are involved in the discussions and will keep the entire faculty apprised of any developments.
- Dean Land reminded faculty that the Honors and Awards Committee was still taking nominations for the Honors and Awards Ceremony, scheduled for Friday, May 16. They still need the \$25.00 contributions from a number of faculty members. Also needed are faculty members to present awards at the Ceremony.
- The last faculty meeting for this semester will meet next Tuesday, May 13 at 3:00 in the King Room.

Action Item - Faculty Appointment Committee - Discussed how, in consultation with the clinic faculty and the Natural Resources Program faculty, they reached a consensus to search for a general clinical faculty member in 2014-15.

The Natural Resources faculty agreed to support a hire for a general clinician (and to not seek a natural resources clinician at this time) in exchange for the agreement of some but not all of the clinicians present to:

- 1. Make a serious, good faith effort to offer a Natural Resources clinic section by the Fall of 2016, if not sooner.
- 2. Work together with the Natural Resources faculty to plan for and build a more permanent Environmental Law Clinic section, with an eye toward replacing Professor Gauna with a core Natural Resources clinician (rather than a core doctrinal professor) when Professor Gauna retires.

The Appointments Committee proposed that the faculty endorse this agreement. The faculty voted in favor of the proposal.
