## **Announcements**

- Admissions report Asst. Dean Jeffery Dubinski-Neessen –To date, 702 applications have been received, which is 9.7% higher than last year. Also, Accepted Applicants day events take place on Friday, March 27. Thank you to faculty for being available to participate.
- Honors & Awards Prof. Jenny Moore requested that recommendations be submitted by Friday, March 27 at 4pm.
- Art Gallery Opening Prof. Sherri Burr reminded everyone that the opening of the current art show is this evening at 5pm. She invited everyone to attend.
- Visiting Faculty for 2015-16 Joining us for Summer and Fall 2015 semester is Prof. Cheryl Fairbanks, teaching in the Southwest Indian Law Clinic. Fall 2015 semester: Prof. Leonard Cavise from DePaul University, teaching Criminal Law; and Prof. Sarah Steadman, teaching Family Law/ Elder Law.
- New Mexico Bar Exam Dean Herring met with members of the New Mexico
  Bar Examiners. The Board members would like to explore alternative paths to
  bar admission with Law School faculty. They think this makes sense as the state
  moves to the Uniform Bar Exam and a different approach to grading the bar
  exam. Dean Herring is referring this matter to two faculty committees –

**Action Item** – Library Director Search – the Ad hoc committee (Prof. Leo Romero, Alexandra Siek, David Stout, Moses Moya) presented their reports on candidate Michelle Rigual's application in the areas of scholarship, teaching, student and staff evaluations, and references. **Discussion Item** – LLLT (Limited License Legal Technician) – The Access to Justice Commission would like a faculty representative on the Committee for their review and discussion of this topic. The Dean asked faculty members to let him know if they would be interested in representing the law school in this discussion.

**Discussion Item** – Expectations of Scholarship for tenure review process – Dean Herring addressed the faculty about wording in the current policy that may be considered vague. The decision was made among those present to consider further discussion of this topic at a future faculty meeting.
