Meeting called to order by Dean Hart. He spoke regarding successful passage of the bill for the law school addition. He pointed out that ours will be the first University building funded by the Legislature.

Dean announced that there are openings at the National Science Foundation, University of St. Louis, and Bates College of Law. Also, the Conference of Western Law Schools will meet on April 2 and 3, at Los Angeles.

Professor Teitelbaum, Chairman of the Faculty Appointments Committee, continued the discussion regarding faculty positions, recommending that offers be made to Robert Schwartz and to Richard Gonzales. The motion by Professor Ellis that the Dean present offers to each of these applicants carried. Professor Flickinger moved that Richard Gonzales be offered the permanent position if neither is willing to be the visitor. Motion carried.

Dean spoke regarding comparison of law faculty salaries with other law schools, and he announced that he expects that the old, more formal diploma will be used starting this year.

Professor Walker presented the report of the Library Committee. After discussion, the faculty agreed, if funding for only one position in the library is granted, that the position be a reference librarian even if this means that the present half-time research position must be abolished.
