MINUTES

1. The meeting was called to order by Dean Hart. The minutes of the December 13, 1976, meeting were approved.
2. The Dean made announcements about fellowships and deanship searches.
3. The petition of Duane Birdbear to be allowed to drop Commercial Transactions 1C for the fall semester was denied. His petition to be allowed to take an incomplete in that course was also denied.
4. The faculty voted to delegate to the Dean the power to act upon requests from students that they be allowed to take less than 12 credit hours.
5. The Dean announced that there might be a problem with one first-year student who apparently did not earn a baccalaureate degree before entering law school.
6. There was an extended discussion about a student whose LSAT score has been cancelled. The faculty voted to establish a committee to recommend the proper procedure to be followed in this case. A motion to require that a student serve on the committee failed, but the Dean indicated that he would appoint one if practicable. The Dean appointed Professor DuMars and Ragsdale to the committee and instructed the committee to report to the faculty at a special meeting to be held on Friday, January 14, at 12:00 noon.
7. The Dean announced that the faculty would meet on Friday, January 14, and Monday, January 17.

The meeting was adjourned.
