MINUTES

Meeting was called to order, and minutes of the meeting of December 12, 1977, were approved.

Dean Hart made announcements concerning the following:

1. National Endowment for the Humanities will conduct a Summer Humanities Seminars for Law Teachers beginning June 26, 1978, paying a stipend of \$1,875.00.
2. Project for the Study and Application of Humanistic Education in Law is sponsoring an educational program for law teachers entitled "The Application of Humanistic Education to Law Teaching," to be held July 29, at Columbia University.
3. Arguments before the U. S. Supreme Court have been recorded on tapes since 1955. These tapes are now available for instructional and scholarly purposes.
4. The AALS summer law teaching clinics will be held this summer at Notre Dame University.
5. Deanship searches are being conducted by Gonzaga School of Law, University of Baltimore School of Law, New England School of Law, Seton Hall University School of Law, and University of Missouri-Kansas City.
6. The Conference of Western Law Schools will be held in San Diego, March 31 - April 1.
7. The Office for Improvements in the Administration of Justice announces individual research grants up to \$10,000.00.
8. Southern University Law School seeks applications for law teaching positions.
9. The ABA announces a new position, Director, Professional Responsibility and Discipline, for which applications are sought.
10. Phone service and furniture for the addition are being delayed a short while more.
