WHEREAS, the State of New Mexico is proud of the distinguished record of the American Indian Law Center, Inc., and the credit it has brought to the state and its University, and is proud that the establishment of a distinct Indian-controlled organization is evidence of the cooperation and mutual respect which represents the finest traditions of Indian-non-Indian relations in New Mexico;
