MINUTES

The meeting was called to order by Dean Desiderio; minutes of the meeting of July 30, 1980, were approved. Dean Desiderio announced:

- a) The ABA has changed the work rule from a limit of 15 hours to 20 hours of permitted outside work.
- b) The Law School is working with the District Court to establish a judicial extern clinic.

Also, he reminded the faculty to return the green biographical forms required by the University or to submit the biographical information he requested, and to be aware of security in the building, as there have been some burglaries recently.

The faculty then considered the petition of Jose Romero to return to law school. Motion to deny his petition carried.

The faculty voted to permit Anthony Carabajal to submit a petition in January to continue in law school, since he wishes to stay out of school during the fall semester.

The faculty then considered George Chavez's petition. It was moved that his petition to continue on probation be granted, provided he enroll for only the four courses listed in his petition, subject to change only with permission of the Dean or Associate Dean. Motion carried.


In response to Terry Seaton's petition that he be permitted to continue his legal studies, the faculty voted to allow Mr. Seaton to return to the law school in the fall, 1981, as a first-year student, on condition that he participate in no outside activities of a voluntary or compensatory nature during the year.

Hart moved that the faculty classify Mr. Seaton's one-year absence as a "required leave of absence" and that his academic record indicate such. Motion carried.

The petition of Gary Willis to continue in law school was granted.
