MINUTES

Dean Desiderio called the meeting to order; minutes of the meeting of December 23, 1980, were approved.

The faculty voted on committee recommendation that Mike Browde be granted a position of associate professor of law, on probationary status toward tenure, with a two to three year tenure decision date. Motion carried.

The election of a representative to the faculty senate, as replacement for Stelzner, was postponed until consultation with absent faculty members.

Dean reminded the faculty that incomplete grades must be removed by the end of the next semester in which the student is enrolled. This University rule applies to summer school enrollment as well as to fall and spring courses. He also stressed the importance of submitting grades for the fall semester, especially for upper classes.

There may be a meeting next Monday, January 26, to consider the academic problems of some students. If sufficient grades have been submitted to Lou Camp, the Dean will call a meeting.


The Moot Court team is leaving for New York next Monday to compete in the national competition. Goldberg may need judges for rehearsals and would appreciate volunteers from the law faculty.

The New England School of Law and North Carolina Central School of Law are looking for deans; the University of Massachusetts needs a professor of business law; and Pennsylvania needs a director of an administrative justice program.

Dean announced that the law school has money available for student researchers; any faculty member who needs research help from a student who does not qualify for work-study money should see Winograd. There will also be money available for a few faculty summer research grants.
