Dean Desiderio called the meeting to order; minutes of the meeting of April 19, 1982, were approved.

Dean indicated that work-study students were available this summer, and that a limited number of student research assistants would also be available. He further mentioned that no student would be hired for more than 20 hours.

Goldberg, Chairman of the Curriculum Committee, read the list of probable adjunct professors for the coming academic year. After distribution of a new curriculum handout, the faculty voted affirmatively on the Committee's recommendations, subject to possible fine-tuning.


The Committee's recommendation that we offer more required courses in the second and third years was discussed. There was a motion to table the present recommendation and to direct the Committee to plan a series of discussions during next year to aid in deciding whether or not there should be required courses, and, if so, which courses. Motion carried.

Dean suggested that meetings of faculty members be scheduled in order to exchange views as to advice and recommendations given to students for curriculum choices.

Also, he reminded the faculty to get examinations questions to Janet Cox and to obtain student evaluations as suggested at the April ~~12~~⁵th meeting.

Minutes of Meeting - April 26, 1982
