

Law School Faculty Meeting  
May 2, 1988  
Dean's Conference Room, 4:00 PM

Dean's Announcements:

Professor Bergman was presented a bouquet and toasted by the faculty in celebration of her passage of the New Mexico State Bar Exam.

The Dean also congratulated Professors J. Ellis and Luckasson for being lauded in an recent editorial in the Philadelphia Inquirer regarding their work on obtaining equal justice for the mentally retarded.

Associate Dean Winograd's report to the Dean on Law School Printing was distributed to the faculty. The report summarized other law schools' procedures for handling in-house printing. Dean Parnall announced that a new system for recapturing a larger portion of Law School copying costs must be in place by July 1, 1988. The faculty were asked to review this report and forward suggestions for improvements to the Dean.

Report of the Continuing Legal Education Committee:

Professor Nathanson reviewed the draft report of the Committee, which had been distributed earlier. The Committee's basic initial recommendations were 1) the need to determine the Law School's proper role in the provision of continuing legal education, 2) developing adequate cost accounting procedures, and 3) establishing a permanent standing faculty committee on CLE.

Ms. Jenkins-Smith reported on student enrollment in CLE courses during the 1987-88 academic year. The consensus of those faculty present was to ask that a CLE Committee consider the issue of limiting the number of courses law students may take from adjunct faculty.

After further discussion, a motion that the Dean appoint a permanent standing faculty committee on CLE, which would serve on an annual basis, was approved.

Other Business:

Professor Morse announced that a reception honoring UNM's first Law Librarian, Arie Podlervaart, is planned for May 20, 1988 at the President's House. All are invited to attend this event, which is scheduled from 5:00-7:00 PM.

Professor Hermann presented a petition to the faculty on behalf of Virginia Lucero to extend the deadline for removing an Incomplete grade. After proper motion and second, the faculty approved an extension to December, 1988.

Professor Occhialino announced that Ed Fuge has generously established an award in honor of the late Professor Helene Simson for the outstanding law student writing requirement. Requirements for faculty certification of the writing requirement and nomination of outstanding papers for this award were reviewed.

Professor Hermann announced that there is a CLE offering on arbitration this weekend at the Convention Center. All were invited to participate.

The minutes of the meeting of April 18, 1988 were approved as written.

The meeting was adjourned at 5:00 PM.
