Report on Public Administration Affiliation with the Law School:

Bruce Perlman, Director of Public Administration School and Lee Brown, former Director of Public Administration addressed the faculty to explore the possibility of affiliating with the School of Law. They are exploring affiliation with three existing units: Law, Anderson and Architecture and Planning. Affiliation can range from very loose association to direct reporting. Some associations with the Law School already exist, like the Hatch Professorship. The faculty discussed background of requirement to examine affiliation and targets of opportunity. Major issue is extent to which schools can cooperate. Dean Romero proposed to raise question at another faculty meeting to discuss joint-faculty committee to discuss relations.

Report of National Resource Center: Lee Brown reported on Natural Resources Center as part of Law School and gave a general report and touched on ideas and search for ideas as to next five year plan. **Focus:** Interdisciplinary teaching, research and service; MWRA, Rio Grande Consortium and State Water Planning. **Major problem of center is** space. It operates in three different locations. This makes doing interdisciplinary work difficult.

Faculty Recruitment Committee Report: Bob Desiderio reported on available position. So far, 425 applications have been submitted for one full-time position. This number does not include AALS registry (about 1000 names) or Stanford, Yale or Temple registries. At this point we are scheduled to go to AALS Convention where we plan to contact those who have applied to us. About 10 percent of the applicants are faculty at other schools. Visiting pool has 19-20 pure visitors.
