The meeting was called to order by Dean Leo Romero.

A motion was made by Professor Ruth Kovnat and seconded by Professor Ann Scales to approve the minutes of the February 10, 1997, faculty meeting as distributed. When voted on, the motion carried.

## Dean's Report:

Dean Romero commended the members of the 1996-97 Jessup International Moot Court Team for their fine showing at the regional competition held in Houston, Texas, February 14 and 15, 1997. The team members are Jennifer Cutcliffe, Arianne Mesco, Anh Nguyen, Bert Parnall, and Elaine Ramirez, and Franklin Gill served as coach.

Professor Margaret Montoya will receive an Affirmative Action Award from the Albuquerque Human Rights Board at its Eighth Annual Awards Ceremony March 5, 1997.

Professor Margaret Montoya will serve on the 1998 AALS Conference on Clinical Legal Education Planning Committee.

Critical Race Feminism: A Reader has been published by New York University Press. Professor Margaret Montoya is among the contributors.

Professor Al Utton was one of the presenters at the 15<sup>th</sup> Annual Water Law Conference on February 20, 1997, in San Diego. The title of his presentation was "Historical Perspective on the Rio Grande Compact: Legal and Institutional Constraints." Professor Utton will also be a presenter at the Transnational Water Projects International Conference in Dundee, Scotland, June 11-13, 1997.

A presentation given by Professor Charles DuMars at the 42<sup>nd</sup> Annual Rocky Mountain Mineral Law Institute, "Public Policy Considerations in State Water Allocations and Management," has been included in the published proceedings of the Institute.

Professor Sherri Burr's article, "Protecting Business Secrets in National and International Commerce," has been selected for inclusion in the 1997 *Intellectual Property Law Review*. It was judged as one of the best intellectual property law review articles recently published.

Arthur Kinoy will speak at the Law School on Monday, March 10. His appearance will be sponsored by the National Lawyers Guild.

Professor Scott Taylor reported that two teams from the UNM School of Law competed at the National Native American Law Students Moot Court Competition February 18 and 19, 1997, at the University of Wisconsin Law School. Randy Castellano and Helen Padilla advanced to the final sixteen teams, and Valerie Davidson and Jaeleen Kookesh advanced to the final eight teams. Ms. Davidson and Ms. Kookesh received an award for the third best brief. The Dean and faculty commended these students on their fine performance.

#### Approval of December, 1996, Graduates:

Dean Romero presented the list of December, 1996, graduates to the law faculty for approval. The faculty unanimously approved the list as presented.

## Associate Library Director/Head of Public Services Position - Proceed or Postpone:

Dean Romero reported that three candidates have come to the Law School to interview for the position of Associate Library Director/Head of Information Services. He has received requests from some Library staff members to postpone the hiring of the Associate Director until after Judith Anspach's position is filled. Professor Barbara Blumenfeld, Chair of the Search Committee, spoke on behalf of the Committee, reporting that the majority opinion of the Committee is to proceed with the hiring of the Associate Director in order not to disrupt services. A motion was made by Professor Richard Gonzales to proceed with the hiring of the Associate Director. Professor Margaret Montoya seconded the motion, and when voted on, the motion carried.
