The meeting on Tuesday, August 28 will deal solely with the dean search and the qualities the faculty wants the new dean to have. Along that line, you should refer to the self-study and the site evaluation team report. Both documents provide valuable information about the future needs of the law school.

The meeting will be limited to only full-time members of the faculty.

We have received questions concerning committee assignments. Although the composition of committees has almost been complete, I have delayed in announcing assignments, waiting to learn who the faculty members of the dean search committee will be. I tried to avoid forming committees only to have to re-constitute them after learning the composition of the dean search committee. 

Dean's Report:

Dean Desiderio announced that the Provost has appointed the Dean Search Committee for the School of Law. The Chair of the Search Committee is Roger Schluntz, Dean of the School of Architecture and Planning, and the members of the Committee are Professor Rob Schwartz, Professor Tim Canova, Professor Antoinette Sedillo-Lopez, Professor Marsha Baum, Paul Nathanson, Cyndi Dean, Peggy Lovato, Andrew Knight, The Honorable Tommy Jewell, Steve Aguilar, and Karl Gillson. Dean Schluntz would like law faculty to call prospective candidates and urge them to apply, or, if they prefer, forward names to him and he will make the calls.

Dean Desiderio reminded the faculty of the Distinguished Alumni Achievement Award Dinner honoring Anne Thomas, Raymond Sanchez, and John Cooney, to be held October 5.

Dean Desiderio announced that the 2001 Granada Exchange Visit scheduled for October 1-4 would be postponed to a later date because of the uncertainty of air travel at this time.

Professor Leo Romero will coordinate the next WTC Tragedy Teach-In on Wednesday, October 3, 11:30 a.m. to 1:00 p.m., entitled "The Tension Between Liberty and Security in the Aftermath of the 9/11 Terrorist Attacks."

Military Recruitment Policy

Dean Desiderio gave a brief history and background of the UNM Law School policy regarding oncampus interviewing of students by the military, in light of a request by Captain Travis L. Rogers of the US Army JAG Corps to recruit on campus on October 5. The policy states "The University of New Mexico School of Law is committed to providing equal educational opportunity and forbids discrimination. The School of Law, therefore, maintains a policy of equal opportunity for its students to obtain employment without discrimination on the basis of race, color, religion, national origin, physical or mental handicap, age, sex, sexual orientation, marital status, ancestry, or medical condition." When anyone calls to make a placement interview reservation they are informed placement services at the Law School are available only to employers whose policies are consistent with the above Law School policy.

The military is taking the position that the Solomon amendment rule means that the access given to the military must be equal to that of other employers. So if other employers are allowed to interview in the law school, so must the military, according to the military. Some law schools have moved all their recruiting activities out of the law school, and, therefore, the military is not allowed in either. If any unit of a university prohibits the military from recruiting, the whole university can lose Department of Defense funds.

Dean Desiderio distributed a document listing DOD funding agencies that have provided over \$2 million each to the University of New Mexico.

The University of New Mexico allows the military to recruit on campus. Their written policy differs from the Law School's only in that the word "unlawful" appears before the word "discrimination" each time.

The current AALS position is that if faced with the risk of losing federal funds, a law school can allow the military in. The law school is then required to ameliorate the military's presence by posting notice that the military's practices are inconsistent with the law school's nondiscrimination policy and taking other steps to ensure a positive environment for gay students.

Eric Locher, President of LAMBDA, stated that if the military recruits at the Law School, they are planning a strong vocal and educational presence in the Forum in order to use it to their advantage.

Dean Desiderio reported that he has spoken with and received e-mail messages from the student veterans' organization and other groups urging the Law School to allow the military to recruit on campus.

After discussion, a motion was made by Professor Occhialino to reinsert the word "unlawful" into our policy before the word discrimination in both sentences. The motion was seconded by Professor Barbara Blumenfeld. When voted on, the motion failed.

Time Allowed for Completion of Incompletes

Associate Dean Peter A. Winograd distributed a document stating the present Law School policy on Incompletes and made a motion to adopt the proposed change:

If the course requirements are not completed within a five (5) month period after receipt of an "Incomplete," the instructor will be asked to submit a grade of "F" for the student, unless strong justification can be made for a grade of WP (withdraw pass).

The motion was seconded by Professor José Martinez, and discussion followed. Dean Desiderio tabled the motion until the next faculty meeting in order to redraft the proposed policy and gather more information.

Election of Faculty Senate Representative

A motion was made by Professor Margaret Montoya nominating Sherri Burr to serve a two- year term on the Faculty Senate. The motion was seconded by Professor April Land, and Professor Burr was elected by acclamation.

Election of Law School Representative to the AALS House of Representatives

A motion was made by Professor April Land nominating Associate Dean Peter Winograd to serve as the law school representative and Margaret Montoya to serve as the alternate to the AALS House of Representatives. Dean Winograd and Professor Montoya were elected by acclamation.

New Business:

Professor Leo Romero read a statement entitled "Defense of Freedom" and moved the faculty go on record as adopting the statement. The motion was seconded by Professor Margaret Montoya, and discussion followed. The consensus reached by the faculty was since this was a political issue unrelated to the law school, the statement should be signed by faculty members on an individual basis.

The meeting adjourned at 5:45 p.m.
